### Proposition 39 Requirements

The Committee received Board Policy and Regulations, and Martin made note to pages A2 and A3, stating the Role of this committee.

Mr. Blasman questioned whether the committee made decisions as to where monies would be spent, and Mr. Klauss responded that the ultimate decision would come from Board of Education, not the committee.

Mrs. Washburn questioned whether the committee is covered for liability by insurance. Martin will check on this and get back to her.
