ISSUE:

To receive a report outlining the enrollment projections for school year 2012-13 and to initiate discussions regarding the number of new District of Choice applications that may be enrolled into the District for next year.

BACKGROUND:

Each year the governing board must determine the number of District of Choice applications that can be accepted and enrolled into OPUSD for the following school year. The window for applications for next school year opens November 1, 2011 and closes December 31, 2011. At the December 6, 2011 board meeting the board will take final action on the number of interdistrict students that can be enrolled. The lottery for identified openings at each grade level will take place during the regularly scheduled board meeting on January 17, 2012. The target enrollment for school year 2012-13 is 4,250, about 50 more students than what the district's current enrollment is as of November 1, 2011.

Information will be presented to the board outlining the projected enrollment numbers based on the grade level cohort moving forward to a new year. In addition, a calculation adjustment of -3% to the high school numbers is factored in to account for the number of no shows that have historically impacted our enrollment projections at that level. The board has established a 35% cap for out of district student enrollment based on the total district enrollment. The percentage for school year 2011-12 is currently at 35%.
