SUBJECT: C.6.a. APPROVE CONTRACT FOR NON-PUBLIC SCHOOL FOR SPECIAL EDUCATION STUDENT #11-12/13 \$12,965.60.
ACTION

ISSUE: Should the Board of Education approve this contract for non-public school for this student?

BACKGROUND: This fourteen-year-old, eighth grade student is placed in a residential program (Forest Heights) and attends a non-public school at the residential facility. The IEP team has determined that the non-public school at the residential facility is the least restrictive appropriate placement at this time. The non-public school is a certified non-public school. The cost of this placement is \$170.60 per day for 76 school days, or \$12,965.60 for the remainder of the 2012-2013 school year (April 16 – June 30).

ALTERNATIVES: 1) Fund this residential program placement.
 2) Do not fund this residential program placement.

RECOMMENDATION: Alternative #1

RATIONALE: The District is required by law to provide the services stated on a student’s IEP. Forest Heights is a certified residential program.

SUBJECT: C.6.b. APPROVE CONTRACT FOR RESIDENTIAL PROGRAM FOR SPECIAL EDUCATION STUDENT #12-12/13 - \$21,465.00.

ACTION

ISSUE: Should the Board of Education approve this contract for a Residential Program (room and board and mental health services) for this student?

BACKGROUND: This fourteen-year-old, eighth grade student has been placed in a residential program per the recommendation of the IEP team. The Ventura County SELPA will reimburse districts for room and board and mental health costs for residentially placed students for the 2012-2013 school year. Forest Heights is a certified residential program. The cost of the placement is \$202.50 per day for 106 days, or \$ 21,456.00 for the remainder of the 2012-2013 school year (April 16 – June 30).

 2) Do not fund this residential program placement.

RECOMMENDATION: Alternative #1
