  Updated policy includes new language re: Superintendent's authority to determine the methodology to be used in calculating grade point average.

  Retitled policy contains new language directing the Superintendent to collaborate with local law enforcement and the city or county to develop vandalism and graffiti prevention strategies, to investigate certain incidents of vandalism or graffiti pursuant to the district's non-discrimination policies, as appropriate, and to cover up graffiti as soon as possible.
- e. Approve Amendment of Board Policy 5145.9 Hate Motivated Behavior Second Reading
  63
  Policy updated to explicitly prohibit discriminatory behavior or statements that degrade an individual on the basis of a protected category of discrimination and to provide for multiagency collaborations to promote safe environments for youth.

  Revised policy reflects change in state's Tobacco-Use Prevention Education program to a competitive grant program for grades 6-12, effective July 1, 2009. Policy also 1) adds exception to student discipline for the possession or use of prescription tobacco products; 2) aligns tobacco-use prevention instruction with state standards; 3) clarifies that districts may make cessation/intervention services available by providing referrals; 4) expands section on "Program Planning" to add establishment of advisory council; and 5) adds new section on "Program Evaluation."

### OAK PARK UNIFIED SCHOOL DISTRICT **RESOLUTION #09-21** CLASS SIZE REDUCTION – K-3

WHEREAS, The State of California, through Senate Bill 1777, has continued a Class Size Reduction Program for 2009-10 and

WHEREAS, The Class Size Reduction Program was established through legislation on July 15, 1996, and

WHEREAS, The Board of the Oak Park Unified School District signified its intent to participate in the program; and

WHEREAS, The administration has selected kindergarten, first, second and third grade classes to participate in the Class Size Reduction Program; and

WHEREAS, The Oak Park Unified School District is implementing the Class Size Reduction Program as set forth in Education Code, commencing with Section 52120, Part 28;

NOW THEREFORE, BE IT RESOLVED that the Board of Education of the Oak Park Unified School District certifies that:

1. The number of classes listed on the application form under Option One and Option Two in each eligible grade level is correctly identified.

The pupil counts do not include special education students enrolled in special day classes, or pupils enrolled in independent study, and are not greater than enrollment as of October of the previous calendar year.

3. A certificated teacher has been hired by the school district and is providing direct instructional services to each class selected for the Class Size Reduction Program. There will not be more than an average of 22.44 pupils per such class. It is the intent of the school district that each such certificated teacher will provide direct instructional services to each pupil enrolled in the separate class to which the teacher is assigned.

As part of the district's Class Size Reduction Program, the district will provide a staff development program for any teacher who will participate for the first time in the Class Size Reduction Program and provide direct instructional services for reduced-size classes in this program. Appropriate training to maximize the education advantages of class size reduction will be provided to such teachers. This training shall include, but not be limited to, methods for providing each of the following: (1) individualized instruction, (2) effective teaching, including classroom management in smaller classes, (3) identifying and responding to pupil needs, and (4) opportunities to build on the individual strengths of pupils.

5. The school district will collect and maintain data required by the Superintendent of Public Instruction for evaluation of the Class Size Reduction Program. The data shall include, but not be limited to, individual test scores or other records of pupil achievement. Any data collected will be protected in a manner that will not permit the personal identification of any pupil or parent.

6. Priority for reducing class size is according to the following order at each school site:

If only one grade level is reduced, the grade level will be 1<sup>st</sup> grade
If two grade levels are reduced, the grade levels will be 1<sup>st</sup> and 2<sup>nd</sup> grades

If three or four grade levels are reduced, the grade levels will be 1st and 2nd and then any combination of kindergarten and/or 3rd grade.

The Class Size Reduction Program has been implemented for 2009-10.

### Health And Welfare Benefits

The district shall provide health and welfare benefits for certificated and classified employees in bargaining units in accordance with state and federal law and subject to negotiated employee agreements.

Employees who are not in bargaining units shall receive the same benefits as those specified in the appropriate Certificated management, and supervisory employees who are not in bargaining units shall receive the same health and welfare benefits as those specified in the collective bargaining agreement for certificated employees. Classified management, administrative and supervisory employees who are not in bargaining units shall receive the same health and welfare benefits as those specified in the collective bargaining agreement for classified employees.

### Non-custodial Parents

The Governing Board recognizes the right of parents/guardians to be involved in the education of their children and desires to balance that right with the district's need to ensure the safety of students while in school.

The parent/guardian who enrolls a child in a district school shall be presumed to be the child's custodial parent/guardian and shall be held responsible for the child's welfare.

School officials shall presume that both parents/guardians have equal rights regarding their child, including, but not limited to, picking the student up after school or otherwise removing the student from school, accessing student records, participating in school activities, or visiting the school. When a court order restricts access to the child or to his/her student information, a parent/guardian shall provide a copy of the certified court order to the principal or designee upon enrollment or upon a change in circumstances.

Non-custodial parents generally retain the same rights as custodial parents unless a court order restricts the rights of the non-custodial parent. These rights include but are not limited to accessing his/her child's student records, participating in school activities and visiting the child at school. If a completed or pending legal action curtails the non-custodial parent's rights, the parent/guardian with custody shall provide evidence of this action to the Superintendent or designee.

The Governing Board believes that grades serve a valuable instructional purpose by helping students and parents/guardians identify the student's areas of strength and those areas needing improvement. Parents/guardians and students have the right to receive course grades that represent an accurate evaluation of the student's achievement.

Teachers shall evaluate a student's work in relation to standards which apply to all students at his/her grade level. The Superintendent or designee shall establish and regularly evaluate a uniform grading system based on standards that apply to all students in that course and grade level. and Principals shall ensure that student grades conform to this system. Teachers shall inform students and parents/guardians how student achievement will be evaluated in the classroom.

A teacher shall base a student's grade Grades should be based on impartial, consistent observation of the quality of the student's work and his/her mastery of course content and district standards. objectives. Students shall have the opportunity to demonstrate this mastery through a variety of methods such as classroom participation, homework, tests and portfolios.

The teacher of each course shall determine the student's grade. The grade assigned by the teacher shall not be changed by the Board or the Superintendent except as provided by law, Board policy and administrative regulation. (Education Code 49066)

# Vandalism, Theft and Graffiti

The Governing Board desires to enhance student learning by striving to provide an environment where students and staff can feel safe and secure and can take pride in their school. To that end the Superintendent or designee shall develop strategies for preventing graffiti and vandalism on school grounds, including collaborating with local law enforcement and city and county officials, as appropriate, to help develop a coordinated response to graffiti and vandalism in the community. considers vandalism a very serious matter. Vandalism includes the negligent, willful, or unlawful damaging or theft of any district owned real or personal property, including the writing of graffiti.

As appropriate, the principal of designee may contact local law enforcement in instances when the graffiti is repetitive, identifies particular targets or groups, identifies the perpetrator, and/or contains incitements to violence, threats, or intimidation. Photographs or other evidence of the vandalism or graffiti shall be preserved as necessary for investigation by the district or law enforcement and as evidence in any district disciplinary proceedings.

The principal or designee shall ensure that graffiti on school grounds is removed and covered as soon as possible, and if practicable before the beginning of the school day.

Any district A student who commits an act of vandalism or graffiti on school grounds shall be subject to disciplinary action which may include, but not limited to, suspension or expulsion in accordance with Board policy and administration regulation. by the district and also may be prosecuted through other legal means. If reparation of damages is not made, the district also may withhold the student's grades, diploma and/or transcripts in accordance with law.

#### Academic Standards

The Governing Board recognizes that content and performance standards are necessary to clarify for students, parents/guardians and staff what students are expected to know and be able to do at each grade level and in each area of study. The Governing Board shall adopt high academic standards for student achievement which that meet or exceed statewide standards and challenge all students to reach their full potential and which clarify what students are expected to know and be able to do at each grade level and in each area of study.

The Superintendent or designee shall provide the Board with recommended standards. In developing these recommended standards, the Superintendent or designee shall use District standards shall be developed through a process that involves teachers, school site and district administrators, Board Members, staff, students, parents/guardians and community members. He/she shall ensure the alignment of the standards with the district's vision and goals and ensure the proper articulation of standards between grade levels.

District standards for English language arts, English language development, mathematics, science, health education, history-social science, physical education, visual and performing arts, world languages, career technical education and preschool education shall meet or exceed statewide model content standards adopted by the State Board of Education or the State Superintendent of Public Instruction as applicable. Standards shall be based on a review of state model standards and an assessment of the skills that students will need in order to be successful in the workplace and in higher education, including basic skills, problem-solving abilities and conceptual thinking. Special care shall be taken to ensure the proper articulation of standards among district schools.

The Governing Board believes that the study of history and other social sciences is essential to prepare students to engage in responsible citizenship, comprehend complex global interrelationships, and understand the vital connections among the past, present, and future. The district's history-social science education program shall be designed to develop students' knowledge of historical events within a chronological and geographic context and shall include, at appropriate grade levels, instruction in American and world history, geography, economics, political science, anthropology, psychology, and sociology.

#### Tobacco

The Governing Board recognizes that tobacco use presents serious health risks and desires to provide support and assistance in reducing the number of students who begin or continue to use tobacco. The Superintendent or designee shall establish a comprehensive program that includes consistent enforcement of laws prohibiting tobacco possession and use by students, tobacco-use prevention education, and intervention and cessation activities and/or referrals. the prevention and intervention of tobacco use among youth.

### **Program Evaluation**

To evaluate the effectiveness of the district's program and ensure accountability, the Superintendent or designee shall biennially administer the California Healthy Kids Survey to students at selected grade levels in order to assess student attitudes toward tobacco and student use of tobacco. He/she also shall annually report to the Board and the CDE on program activities, program expenditures, the number of individuals receiving each type of service or training, progress toward program goals and objectives, and other data required pursuant to Health and Safety Code 104450.

## Alternative Schools/Programs of Choice

The Governing Board desires to provide a variety of *innovative educational* education programs designed to address accommodate students' diverse learning needs and *interests*, foster student engagement in the schools and enhance student achievement. through innovative methods and ideas. Toward this end, the Board may establish and maintain alternative schools or programs of choice. separate class groups within a school in order to fulfill the objectives specified in Education Code 58500.

A district alternative school or program of choice may differ from the traditional educational program in its academic emphasis, sequence of curriculum, educational philosophy, instructional strategy, structure, setting, size, scheduling, targeted student population, decision-making process, and/or other components. All alternative schools or programs of choice shall offer enrolled students the opportunity to acquire the knowledge and skills necessary to achieve district content standards in core academic subjects and shall provide access to the course of student required for high school graduation.

### SCHOOL SITE COUNCIL MEETING:

The School Site Council met on October 27<sup>th</sup>. Agenda items included: landscape architect's drawing of quad project; K-12 Chinese Language Grant ideas; report card conferences; review of field trip liability forms; review benefits of banking time; calendar survey, H1N1 update.

## TECHNOLOGY AND INSTRUCTION:

Smartboards are being used to research and read about authors, share writing, and explore Foss science units. Senteo clickers are providing instant feedback from students to teachers on learning and mastery. Students actually cheered when they saw the graph of 100% correct answers. First grade students found pictures of real bears using the Smartboard. Others used an interactive website to predict and see how temperature affects solids and liquids. Second and fifth graders used the laptop computers for their first buddy activity. Fifth graders taught their buddies how to log in and use basic functions in Word.

#### **RED RIBBON WEEK ACTIVITIES:**

### Oak View

We participated in the Earthquake drop and cover drill held statewide. Our radios work and our search and rescue teams are up and running!

Our teachers now engage in structured peer coaching and observations to enhance their skills. This month, we visited Susan Allen's class to learn about student peer support for writing and editing essays. Teachers will modify and incorporate the strategies in other content areas such as science and history. Our goal is to learn through writing across the content areas. We are also addressing reading comprehension across the content areas

The first Clean Teen trip to the Santa Barbara Zoo was a great success and much fun. Students have been attending our weekly pullout class with our Action Counselor.

We prepare individual teaching plans for all 504 students-detailing *the specific* role of teacher, student and case manager. This is a huge step in clarifying services.

Upcoming field learning experiences include the Griffith Park Observatory on November 3<sup>rd</sup> and the Service Learning Program sponsored by the Coastal Conservancy and the National Park Service. On February 9<sup>th</sup>, we will participate in ecology lessons, nature hike and restoration activity in the Santa Monica Mountains.

#### Independent School

Teachers attended the buy back day professional development workshop on computer technology skills on Monday, November 2<sup>nd</sup>. Our next step is to participate in the Mac book student lab orientation with Jane Mintz. When we complete the training, we will have access to our set of ten student laptops at our Red Oak location. Very exciting!

We are working on obtaining the *Naviance* College and Career Search product for OPIS and Oak View. Pricing is a problem for small schools such as OVHS and OPIS. I am collaborating with OPHS and Medea on several strategies to address the issues. The vendor would like to expand the contract to include Medea and bring us in under the umbrella in some way. The high school is willing to serve our students in some of the on line components, but not in the college planner component because it would skew their data.

Teachers are consulting with Debbie Cooper to review their potential qualification for the HOUSE process for NCLB certification.

Two teachers and I attended the Independent Study Conference in Ontario, CA on October 19-20. The meetings were very informative and productive for all of us.
