WHEREAS, it is currently necessary to not reemploy certain certificated staff for the 2017-2018 school year.

THEREFORE, BE IT RESOLVED by the Governing Board of the Oak Park Unified School District as follows:

- 1. That the Superintendent or designee is authorized and directed to notify those certificated employees listed on Exhibit "B," prior to May 15, 2017, and consistent with Education Code section 44949, that their services, to the extent indicated on Exhibit "B," will be reduced or discontinued by the District for the ensuing 2017-2018 school year.
- 2. That the Superintendent or designee, is authorized and directed to take any other actions necessary to effectuate the intent of this resolution and to finalize layoffs.
