**BACKGROUND:** Effective July 1, 2014, under the State's K-12 Local Control Funding Formula (LCFF) finance system, school districts and County Offices of Education are required to develop, adopt, and annually update a three-year Local Control and Accountability Plan (LCAP), using a form adopted by the California State Board of Education (SBE). The LCAP identifies the District's goals and measurable outcomes for students in a three-year plan, and demonstrates compliance with the State's priorities and metrics in accordance with statutes.

In the middle year of the three-year plan, the 2018-19 Oak Park Unified School District LCAP has been developed with the input from diverse groups of stakeholders. In conformance with Education Code 52062, the District's initial draft of the 2018-19 LCAP was presented at the Board's regular meeting on May 17, 2018. At this evening's meeting a public hearing will be conducted to solicit the comments and recommendations of the public regarding the proposed LCAP. Staff will provide an update and recommendation based on the most current information available, including LCAP recommendations, local budget assumptions, enrollment and staffing projections, and revenue and expenditure forecasts. - **BACKGROUND:** At its meeting on January 16, 2018, the Board of Education approved an architectural services agreement for Project 17-35S, Kitchen Improvements at Medea Creek Middle School with HED Architects, in the amount of \$125,200. HED has prepared plans that have been approved by the Ventura County Health Department and the Division of the State Architect (DSA). Subsequent to receiving the approval of those agencies, the District has identified modifications to the project that it would like incorporated prior to releasing its Request for Bids for this project. Those changes, which include revisions in the dishwashing area layout and equipment floor plan, addition of an ORCA food disposal system, and related utility modifications, will increase the original scope of construction and require additional architectural design services. HED Architects has submitted the following proposal for these services, in the amount of \$14,000, which includes \$800 for reimbursable expenses. After review and recommendation by the Measure S Facility Subcommittee, it is respectfully requested that the Board ratify the amendment to the architectural services agreements with HED Architects for Project 17-35S, Kitchen Improvements at Medea Creek Middle School as proposed.

## Dress And Grooming

The Governing Board believes that the purpose of a student dress-and appearance code regulations is to encourage students to dress appropriately forto attendance at school and to adequately prepare them for participation in the educational process. Dress code policies should also protect the health, safety, and welfare of all students.

The primary responsibility for a student's attire resides with the student and his/her parents/guardians. There District-is an expectations that all students will dress in a way that is appropriate for the day or any school-sponsored event.

The Governing Board further believes:

- 1. All students should be able to dress comfortably for school without fear of or actual unnecessary discipline or body shaming due to attire.
- 2. All students and staff should understand that they are responsible for managing their own personal "distractions" without impinging upon another regulating individual student's choice of clothing/self-expression.
- 3. Students should not face unnecessary barriers to school attendance.
- 4. Dress codes and administrative enforcement of such should not reinforce or increase marginalization or oppression of any group based on, including but not limited to, disability, race, gender, ethnicity, nationality, immigration status, religion, sexual orientation, household income, gender identity, gender expression or cultural observance.
- 5. Reasons for conflict and inconsistent discipline due to attire should be minimized whenever possible.

Students and parents/guardians shall be informed about dress and grooming standards at the beginning of the school year and whenever these standards are revised.

(cf. 4119.22 - Dress and Grooming) (cf. 5145.2 - Freedom of Speech/Expression) (cf. 5144 - Discipline)

## Gang-Related Apparel

The principal, staff and parents/guardians at a school may establish a reasonable dress code that prohibits students from wearing gang-related apparel when there is evidence of a gang presence that disrupts or threatens to disrupt the school's activities. Such a dress code may be included as part of the school safety plan and must be presented to the Board for approval. The Board shall approve the plan upon determining that it is necessary to protect the health and safety of the school's students.

## Dress and Grooming

In cooperation with teachers, students and parents/guardians, the principal or designee shall establish school rules governing student dress and grooming which are consistent with law, Governing Board policy and administrative regulations. These school dress codes shall be regularly reviewed.

(cf. 0420 - School Plans/Site Councils)

Each school shall allow students to wear sun-protective clothing, including but not limited to hats, for outdoor use during the school day. (Education Code 35183.5)

Freedom of expression is a right guaranteed to all students. Each student's dress-and personal appearance is, within certain limits, a matter of personal style and individual preference. Each school shall have the latitude to prohibit the wearing of any clothing, attire, apparel or accessory which is hazardous to or disruptive of the learning environment, or which interferes with the health and safety of other students. Each school principal, in cooperation with teachers, students, and parents/guardians, may establish school rules governing student attirewear and personal appearance, yet restrictions that are imposed must be necessary to support the overall educational goals of the school.

The District and individual schools are responsible for seeing that student attire does not interfere with the health or safety of any student. Schools shall have latitude to prohibit the wearing of clothing, shoes or accessories which are hazardous to or disruptive of learning environment.

The following guidelines shall apply to all regular school activities:

- 1. Students must wear clothing including both a shirt with pants or skirt, or the equivalent (i.e. dresses, leggings, or shorts) and shoes or sandals.
- 2. Clothing must cover the chest, back, buttocks, and torso.
- 3. Clothing must cover undergarments.
- 4. Clothing must not be see-through.
- 5. Clothing may not depict, advertise or advocate the use of alcohol, tobacco, marijuana or other controlled substances.
- Clothing may not use or depict hate speech targeting groups based on, including but not limited to, disability, -race, gender, ethnicity, nationality, gender, immigration status, religion, sexual orientation, household income, gender identity, gender expression, or cultural observancereligious affiliation, immigration status, or any other protected classification.

  8. Clothing must be suitable for all scheduled classroom activities including physical education, science labs, shop classes, field trips and other activities where unique hazards or specialized attire or safety gear is required.
  - 9. Hats and other headwear must allow the face to be visible to staff. Masks are not allowed.

Coaches and teachers may impose more stringent dress requirements to accommodate the special needs of certain sports and/or classes.

## (cf. 3260 - Fees and Charges)

No grade of a student participating in a physical education class shall be adversely affected if the student does not wear standardized physical education apparel because of circumstances beyond the student's control. (Education Code 49066)

## (cf. 5121 - Grades/Evaluation of Student Achievement)

The principal, staff, students and parent/guardians at each school may establish reasonable dress and grooming regulations for times when students are engaged in extracurricular or other special school activities.

## Gang-Related Apparel

At individual schools that have a dress code prohibiting gang-related apparel at school or school activities, the principal, staff and parents/guardians participating in the development of the school safety plan shall define "gang-related apparel" and shall limit this definition to apparel that reasonably could be determined to threaten the health and safety of the school environment if it were worn or displayed on a school campus. (Education Code 35294.1)

Attire or grooming depicting or advocating violence, criminal activity, gang-related activity including attire, logos, or colors identified by Ventura County Sheriff's Department (VCSD), Los Angeles County Sheriff's Department (LASD), or Los Angeles Police Department (LAPD) as gang-affiliated are prohibited.

Students who participate in a nationally recognized youth organization shall be allowed to wear organization uniforms on days when the organization has a scheduled meeting. (Education Code 35183)

## Enforcement

A school dress code is only as effective and fair as its enforcement. Enforcement shall be consistent with a school's overall discipline plan and. Enforcement of school dress codes shall ensure that all students are treated equitably regardless of gender/gender identification, sexual orientation, race, ethnicity, immigration status, body type/size, religion, and personal style. All school staff shall be notified and informed of the policy at the beginning of the school year in regards to its purpose and spirit, and how to enforce it without shaming students or disproportionately impacting certain student groups. Staff should be guided by the dress code policy and follow the letter and spirit of the dress code.

When a school staff member or school administrator discusses a dress or grooming violation with a student, the Board recommends that another adult should be present and at least one of the two adults should be the same gender identity as the student a male and a female adult should be present whenever possible. Unless there is an immediate concern, a student should not be spoken to about a dress code violation in front of other students.

Teachers or staff discussing a dress or grooming violation with a student should present options for obtaining appropriate clothing (e.g. school clothing supply, call home, borrow from a friend).

Teachers should send a referral to the administration when a student is in violation of the dress code.

Whenever possible, students should not be required to wear school owned replacement garments and should never be required to wear specific garments as a disciplinary measure.

Discipline for dress or grooming violations should be consistent with the discipline policies for comparable violations.

The superintendent or designee will ensure that each school site outlines the District and School dress code guidelines in the School Handbook.
