DISCUSSION/ACTION

ISSUE:

Shall the interview and select a candidate for provisional appointment to fill board vacancy?

BACKGROUND:

On November 16, 2021, OPUSD Board Member Allen Rosen announced that he will be relocating from his residence out of Oak Park and will resign his seat on the OPUSD Board of Education. Mr. Rosen submitted his letter of resignation to the Superintendent of the Ventura County Office of Education effective January 19, 2022. On December 14, 2021, the Board voted to fill the vacancy by making a provisional appointment and selected Board President Drew Hazelton and Clerk of the Board Denise Helfstein to form a board subcommittee to work with the Superintendent's office on the process of advertising and screening candidates who are interested in serving on the Board. On December 17, 2021, OPUSD posted the vacancy notice and application packet and advertised it in the Acorn newspaper, on OPUSD social media outlets, and Nextdoor. The written application process to fill Mr. Rosen's vacancy closed on January 18, 2022 at 4:00 pm.

The following four Oak Park residents submitted applications: Carmen Rosenberg Deet Ezra (Yehudit Zucker) Nicholas Johnson Soyon Hardy

All four applicants met the requirements below as required by Education Code 35107.

- 18 years of age or older.
- A citizen of the state of CA.
- A resident of Oak Park.
- A registered voter.
- Are not disqualified by the Constitution or laws of the state to hold a civil office.

The Board members have received a copy of each candidate's application which includes candidate information, references, and answers to candidate application questions. Candidate application materials (with address and phone numbers redacted) are included in the posted Board packet as well.

Candidates will be interviewed one at a time and the other candidates will be requested to wait in the adjoining room out of earshot. Each candidate will be asked the same nine questions.

The Board will deliberate, vote (majority vote required for appointment) for a candidate to fill the Board vacancy.

3. Please describe any relevant community or business activities in which you have participated. Describe your role, duration, and whether your work was volunteer, or employment related.

I believe my business and professional experience will be relevant and may be helpful to the district and board. I've been a corporate lawyer for almost 20 years, representing primarily healthcare providers, and my husband is a physician partner (ER) at Kaiser. Both of us have lived and worked in the Los Angeles area for over 20 years, and trained/attended graduate school at UCLA, so we both have a strong network in the healthcare industry and in both northern and southern CA. We've been Oak Park residents since 2013. I've worked closely with and advised the boards of directors and senior management of startups and Fortune 500 companies and attended numerous board meetings, so am very familiar with corporate governance and how boards function. As a corporate lawyer, I'm also very comfortable reviewing and analyzing financial statements and reports, which I think will be helpful when doing budget and financial reviews. Prior to law school, I worked for Citigroup for 4 years and developed strong sales, management, and financial skills during that time. I've also been the treasurer for my daughter's girl scout troop from 2015-2021.

4. Why do you want to be a school board member?

I've been actively involved with OPUSD schools and other community activities since moving here in 2013, and have come to know and love the community during this time. With the unprecedented challenges that governing a school district during a pandemic brings, and with the transition to a new leadership team at OPUSD, I believe this board vacancy provides a unique opportunity for me to give back, to bring my experience, skills and love of the Oak Park community to bear on the current issues and challenges facing the school district, and to continually improve upon the strong foundation of OPUSD.

5. What do you see as the basic purpose of the public schools? What is the role of the school board in the fulfillment of that purpose?

While I believe there are many purposes to public schools, I believe that their basic purpose is to provide the communities they serve with equitable access to a well-balanced public education in accordance with state and federal guidelines, and to prepare students to be productive and compassionate citizens in an ever-changing world. A good public education in my view shouldn't just focus on one purpose, but rather should be a multi-pronged approach to educating the whole child, helping them reach their potential, and preparing them for life, whatever path that may take. Ultimately, the school district should strive to meet the relative priorities and needs of the community it serves. OPUSD's mission statement sums it up well: "To provide students with a strong foundation for learning which meets the challenge of the present and of the future through a balanced education which includes academic achievement, personal growth, and social responsibility."

As elected public officials entrusted with governing the school district and accountable to the constituents who elected them, the role of the school board is to ensure that the school district is responsive to and reflective of the values, beliefs and priorities of the community it serves. The school board does this by setting long-term goals for the district, establishing budgets and policies in line with those goals and in compliance with state and federal laws, and working with the Superintendent and the administration to implement those goals with a level of accountability.

6. How does the board's role differ from that of the Superintendent?

The role of the board is to provide high-level direction, management and oversight over the school district, and is ultimately responsible for governing the district and accountable to its constituents, much like a company's board of directors is responsible for providing the high level, strategic direction and management of a company and is accountable to its shareholders. The school board must approve all contracts and legal obligations of the school district. The Superintendent is hired by and answers to the school board, and it's the Superintendent's role to manage the day-to-day affairs and staff of the district and to execute on and implement the goals, direction and policies set by the board, just as a company's CEO is hired by a corporate board to manage the day-to-day affairs of a company at the direction of the board.

7. Describe the relationship between board members and the administration in handling school concerns?

While the entire administration is accountable to the board at some level, it is really only the Superintendent who is a direct report of the board. The other administrative staff report to the Superintendent (or their immediate supervisors). School concerns for the most part should be handled at the school site level and elevated as appropriate to the site leader (principal), and if necessary, up the chain to administrative leadership (Superintendent) based on the district's policies and procedures. The board provides high level guidance and direction to the extent a school concern is important enough to have an impact on the district, and it is the administration's responsibility to implement the board's directives.

8. Briefly describe your commitment to public education and our local school district.

My husband and I are big proponents of public schools and public education. While public schools really weren't a viable option for me growing up on Guam, my husband is a product of CA public schools, and both he and I attended CA public universities. My husband and I moved to Oak Park from the Westside 9 years ago for the Oak Park school district after having researched many other communities and school districts in Orange, Los Angeles and Ventura counties. Both my children attended kindergarten at Brookside

Elementary, and my oldest is now a 6th grader at MCMS. We love the small, close-knit and down-to-earth community of Oak Park where your neighbors are your friends and don't hesitate to help one another, and where parents are so involved and invested in the school district. Even while working full-time, I always felt it was important to volunteer and give back where I could, especially in a public school district where funding is a perennial challenge, by volunteering in my children's classrooms to joining PTA/PFA boards and district committees. No school district is perfect, but I believe one should volunteer and get involved to truly understand the unique challenges faced by a public school district like Oak Park, and to try to be as constructive and proactive as possible to help improve it.

10. What do you see as the area(s) most needing improvement in the Oak Park Unified School District?

- A process and management structure for more consistent data-driven policy and decision-making, informed by more rigorous and inclusive stakeholder input
- An immediate need is to advocate for the additional funding and adequate state/federal support needed to (a) identify the curriculum gaps, cumulative learning loss and impact on social-emotional health brought on by the pandemic; (b) develop a long-term plan to close those gaps as best as possible over time, (c) make the necessary and timely adjustments to curriculum, homework load and testing (especially during key transitions from elementary, to middle to high school) taking such learning/curriculum loss into account; and (d) provide teachers and staff with the tools and support they need to implement that plan
- Instilling a culture of continuous improvement
