BUSINESS

- Approved Purchase Orders for the Month ending May 31, 2016
- Approved Resolution 16-16, Ordering a School Bond Election and Establishing Specifications of the Election Order. The bond measure will appear on the November 2016 ballot and, if passed, authorize the District to issue up to \$60 million in bonds at a tax rate estimate of \$60 per \$100K of assessed valuation. This tax will replace the current bond measure tax of \$82 per \$100K that is expiring next year with a less

- expensive tax for a new term. The proposed bond measure has been developed after a year-long comprehensive <u>Needs Assessment Plan</u> was developed that included a variety of stakeholders principals, teachers, parents, community members, and members of the Citizens Oversight Committee.
- Approved 2016-2017 Employee Health Benefit Plans The program with CVT will be continued for another year as recommended by the Health Benefits Committee. The Committee will look at alternative plans over the course of the next fiscal year to compare with the CVT plans in terms of quality, cost, and value
- Approved and Adopted 2016-2017 Oak Park Unified School District Annual Operating Budget.
- Approved Measure C6 Bond Fund Equipment Purchase Maintenance and Operations Vehicle
- Approved Measure C6 Bond Fund Equipment Purchase Multi-Surface Floor Cleaning Equipment

CURRICULUM

HUMAN RESOURCES

Approved Authorization to Re-establish the Administrative Position of Director Curriculum and Instruction. Funding for this position would come from a percentage charged to federal categorical funding, which this position will be overseeing, and by shifting some ongoing expenses to one-time funding due to the nature of the programs.

PUPIL SERVICES

 Approve Contract for Non-Public Placement and Services for Special Education Student #010-15/16.

BOARD POLICIES/ADMINISTRATIVE REGULATIONS

- Approved Amendment to the following Board Policies and/or Administrative Regulations:
 - o Firearms on School Grounds Instruction The Board voted to not allow any individual to carry a concealed weapon on school grounds, even if licensed to do so, with the exceptions allowed in the Penal Code.
 - o Physical Education and Activity
 - o Class Assignments
 - o Married/Pregnant/Parenting Students

- Integrated Pest Management The Board approved administrative regulations that do not allow the application of pesticides, herbicides, or rodenticides except in cases of emergency. Instead, a system of aggressive prevention will be implemented.
- Guidance/Counseling Services Policy was tabled in order to gather additional information from principals and counselors.
